6:00 Pledge of Allegiance

Roll call – all present

Fire Chief discussion of the grant from the Gosselin covered additional 5 sets of gear. The remaining funds must be spent on equipment, gear etc. Chief advised that engine5 has an electric issue. The Chief discussed a fire engine that Buxton is selling. The crossband install should happen on 4/11. Vice Chair Walsworth watched the Buxton Town Meeting and they will put a referendum on the town meeting ballot regarding the fire engine – they are looking for \$30,000.00. Selectman Harlow asked where the money would come from. Chief advised the board that he has cut the staffing in order to save money – trying to avoid a shortfall in the budget. There will be 2 on day and night. The department was notified that they have been accepted in the York County User Group – have 30 days to pay. Chief has ordered 900' of hose. Chair Philbrick asked if the latest donation funds included the previous fire engine purchase of \$10,000. Chief stated the funds were only to be used for equipment.

7:00 Scott Gerrish, Road Commissioner, discussed purchasing a brand-new loader with some attachments. The Road Commissioner would auction off the current loader and backhoe which could bring \$40,000.00. This would go on the November ballot.
