5:42 Public Participation – Dan Blanchette addressed the BOS regarding information that was brought before the BOS last week from Mr. Potter. Mr. Blanchette came to give his version of the story. Bethany Patstone provided paperwork for a 4x4 Event on Memorial Day weekend. She asked the BOS to sign the BYOB so that she could get it to the State asap – they did.
