5:30 Pledge of Allegiance

5:32 Public Participation - David White spoke in support of the BOS. Deborah Wilson reported that James DuPrie has resigned as Treasurer of non-profit and paperwork is being done to appoint a new one. Mr. Walsworth asked the Chair if he contacted the town attorney prior to getting a no-trespass order issued on a resident. Chair Russell sated that he did speak with the town attorney prior, but it was not immediately prior - may have been a year ago. Mr. Walsworth asked the Chair if he attempted to interfere with the verification of signatures for the recall petition while the Clerk was counting. Chair Russell stated he did not. Mr. Walsworth asked questions about using MMA Legal, which is free, instead of the town attorney which is very expense. Mr. Walsworth questioned the legality of Executive Session's and discussed one that was in violation of state statute.
