5:30 Pledge of Allegiance

5:35 Selectman Philbrick motioned to accept the minutes dated 7-23-2020 as written. Selectman Cole seconded. Vote taken; vote carried.

Paper work signed – time off, purchase orders, free training and a document named "Policy Regarding Application of Payments to Unpaid Taxes". The BOS discussed removing Marijuana Ordinances from website that have been voided by the new Ordnances passed 7-14-2020 – Selectman Philbrick will review.

5:43 Greg Bavis, First Responder Grant writer discussed the services the company can provide. The fee for service is \$1500 which provides writing 4 grants and training. The BOS will discuss and get back to Mr. Bavis.

6:10 Kevin and Elaine Hartford request abatements and explain why. Chair Russell motioned that the property at 244 Upper Guinea Road be given an abatement of real estate valuation of \$69541.00 (campers only). Selectman Adams seconded. Vote taken; vote carried. Motions were made by Chair Russell on the other two properties but withdrawn. Chair Russell will speak with Noel of O'Donnell and Associates on the other 2 properties.

6:30 Terri Poirier spoke to the complaints from neighbors about the event last weekend. Ms. Poirier states she put tape over the NO on the No Parking signs as she doesn't believe the Town had the right to put them up. Chair Russell spoke to the issues of camping and parking. Ms. Poirier asked why it is always Eddie B's tow company that is called, there is supposed to be a county list of tow companies. Ms. Poirier believes this is hurting all the other tow businesses in town who have also been doing business here longer than Eddie B's. Chair Russell advises Ms. Poirier to contact the state about the camping permits and other requirements.

Chair Russell asked for nominations for Vice Chair. Selectman Adams nominated Paul Philbrick for vice chair. Selectman Lizotte seconded. Vote taken 4 in favor, 1 abstained (Selectman Philbrick). Nominations closed.
