5:30 Pledge of Allegiance

5:34 Tom Potter read a document that he prepared about Hebo Hybo. There was much discussion about the issues and that the Town and Conservation Commission need to step up with enforcement. Selectman Lizotte stated that residents at the Acton end want that end locked as well.

6:56 Vice Chair Philbrick motioned to accept the Minutes of 4-12-2021 as written. Chair Russell seconded. Vote taken; vote carried. (Selectman Adams absent)

Vice Chair Philbrick motioned to accept the Minutes of 4-13-2021 as written. Chair Russell seconded. Vote taken; vote carried. (Selectman Cole & Adams unable to vote as they were not present at the 4/13/21 meeting).

6:57 Paperwork – Pay increase, Annual Town Meeting Referendum/Warrant, Notice of Public Hearing -- all signed.

7:02 Old Business – Selectman Cole would like to hire a manager for the Transfer Station. Vice Chair Philbrick states that he has been working on posting a Leader position for the Transfer Station. This will be open until filled. Vice Chair Philbrick advised the BOS that Mr. Nass (moderator) would like to clarify that comment/discussion is limited to Lebanon Residents only. The BOS agrees that Lebanon Residents only may comment at the Town Hearing. Vice Chair Philbrick addressed the BOS about a resident that would like to cut trees on Wiswell Lane. There are approximately 18 trees on Town Property. The BOS agrees but he must provide insurance binder. He may only cut pine and specific trees – Selectman Lizotte following up on this. The BOS adds comments to the Town Meeting Referendum/Warrant for the mailer.
