5:30 Pledge of Allegiance

5:31 Public Participation – Eric Kelley discussed his property being taken by Animal Control, Charles Russell and Butch Lizotte. Mr. Kelley provided a police report regarding animals and legal marijuana plants being taken. Mr. Kelly would like his property back. Chair Russell stated that Mr. Kelley will need to take this to Superior Court. There was a lengthy discussion with Mr. Kelley and several attendees. There was a call for Chair Russell and Selectman Lizotte to resign. There was also a call to place both animal control officers, Chair Russell and Selectman Lizotte on unpaid leave and for an investigation to take place. Mr. Bragdon discussed the upcoming Special Election regarding Marijuana Ordinances and making a choice to OPT IN or OUT as that is what the citizens want. Chris Gilpatrick, Sr. addressed openings on the Budget Committee and what will be done. Chris Gilpatrick, Jr. addressed the community getting behind Mr. Kelley and supporting him even though they don't know him. This should not cost the taxpayers money to defend. Matt Leggett stated that he feels the BOS is doing a great job. Michael Wadsworth feels the town should hire an independent investigator. Discussion of the 2019 Audit still not complete.
