5:30 Meeting opened. Pledge of Allegiance.

Lissa Bitterman from Eco Maine presented their facilities and services.

6:40 Public Participation - Questions for Eco Maine regarding food and yard waste recycling.

7:00 Selectman Bragg motioned to accept the minutes of 9/5/19 as written. Selectman Russell seconded. Vote taken; vote carried.

Discussion of the Cannabis Committee going from 5 members to 7 due to the interest in participating. Selectman Cole motioned to increase the Cannabis Committee from 5 members to 7 members. Selectman Russell seconded. Vote taken; vote carried.

7:10 James Duprie and Bettie Harris-Howard will screen and interview candidates and provide the Selectmen with recommendations and turn over all applications. Deb Wilson discussed starting a Grant Writing Committee – because the Committee was previously formed the members will just need new appointment papers.

7:43 Selectman Russell motioned to accept bid for stone work at Prospect Hill Cemetery for \$1500.00 from Grizzlies Tree Service. Selectman Bragg seconded. Vote taken; vote carried. Cemetery Committee is not active – appointment expired. Discussion of Trustees vs. Committee. Paving discussion with Roads. Selectman Bragg discussed a street light at Park-n-Ride. Discussion of 4x4 and Music Festival. Rebid the ambulance.
