5:30 Pledge of Allegiance

5:30 Planning Board update from James Duprie. Discussion about the issue between the Comprehensive Plan and the Planning Board. This will be disclosed at the Public Hearing on 1/11/2020.

5:43 Ben Warren explained to the BOS why he has a vehicle registered in NH and his wife is registered in Maine.

5:45 John Bozak informs the BOS that the Three Rivers Land Trust had been working on Comprehensive Plan. He provided a copy for the Board and advised that there is a copy at the Library as well.

5:50 Reminders of upcoming events: Christmas Tree Bonfire on Saturday 1/18/2020; Fire Department Calendar Raffle for \$10; Rabies Clinic on 1/19/2020; Public Meetings for the Comprehensive Plan will be held on 1/11/2020 at 12:30 and on 2/11/2020 at 5:30.

5:55 Selectman Cole motioned to accept the Minutes of 1-2-2020 as written. Selectman Bragg seconded. Vote taken; vote carried. This week's warrant amount \$581,483.00

5:56 Paperwork presented – time off, purchase order and Memorandum of Understanding – all signed.

6:00 Tim Bragdon, Atty Dion & Atty Fredette all speak to the ongoing issue of the Occupancy Permit. Chairman Russell advised that the Town will issue the Occupancy Permit for a Medical Care Provider. Mr. Bragdon states that is not what the facility is. Attorney Dion speaks to the issue of grandfathering for Mr. Bragdon. Selectman Cole addresses the Attorney – Chairman Russell silenced Selectman Cole for this issue. Selectman Russell states that he had previously motioned to approve but the Motion failed as there is a split Board on this issue. Chairman Russell states that if the majority of the BOS wishes to speak at this time, they may – they did not. Attorney Dion wants it on the record that he attempted to have a conversation on this matter. He also wants to be sure that the recordings on YouTube don't disappear before being subpoenaed.
