5:30 Pledge of Allegiance

Update on Roads – Chairman Russell read an email from Road Commissioner Gerrish who is still working on numbers and should have them next week. The BOS discussed the Paving Bid and asking for some tonnage numbers from the Road Commissioner.

5:36 Matthew Leggett from the Sanford ATV Club presented a document for the BOS to review about access on Lebanon roads. Chairman Russell motioned to allow ATV access on Upper Middle Road and Creamery Hill Road not to exceed one year. Selectman Bragg seconded. Vote taken; vote carried. Vice Chair Adams absent.

5:36 Public Participation – Deb Wilson now has storage for donations for fire victims. Deb Wilson asks if Blood Drives can be held at the Fire Department. The BOS advises that there will be no public allowed in the fire department until the complete investigation is over. James Duprie reported that the Grange meeting was a success and there will be a follow up meeting in 3-4 weeks. 4x4 Proving Grounds presented the BOS with the applications for their spring/summer events.

6:00 Selectman Bragg motioned to accept the minutes dated 3-5-2020 as written. Selectman Philbrick seconded. Vote taken; vote carried. Vice Chair Adams absent.

6:01 Paperwork signed – time off, purchase orders & J&S Masonry Extension.

6:10 James Duprie of the Cannabis Committee explained that the deadlines are very fast approaching due to legal requirements. Mr. Duprie went through the questions he needed answered from the BOS to finalize the Marijuana Ordinance for the ballot.

6:50 Old Business – the complete list was addressed and updated.

6:55 Individual Selectman Issues: Selectman Philbrick asked the BOS when they could meet to work on the budget. The BOS will have a budget workshop on Saturday 3-14-2020 at 8:00AM. Selectman Bragg reminds everyone that the Nomination Papers are available – opening for Selectman, Budget Committee and School Board. Selectman Cole discussed the Cash Handling Policy.
