2:00 pm - Open Meeting - Pledge of Allegiance

- Chairperson Torno made a motion to go into Executive Session pursuant to 1 MRSA § 405(6)(D) to discuss labor negotiations; seconded by Selectman Nadeau, all in favor.

3:10 pm

- Ron Sands, Treasurer of the Northeast Pond Campers Association came before the Selectmen to express concerns about the waterfront assessments on Sewell Shores Road. According to Mr. Sands, then Chairman Ben Thompson went to one of the association's meetings and told the group that their taxes would double. In turn, they contacted the governor and other state representatives. Tim O'Malley also commented that Chairman Thompson said the waterfront tax rate would go from \$42,000 to \$90,000 per foot. These are remarks they said are in the minutes of that meeting.
- Mr. Sands asked the Selectmen if they would support reassessment of waterfront property exclusive of other property in town. Chairperson Torno responded that waterfront property is being addressed this year.
- Mr. Sands and Mr. O'Malley both wanted to express their concerns that this will be done equitably and in a non-discriminatory manner.
- Chairperson Torno explained that assessments going up can bring down the tax rate.
