- Old Business
  - Computers
    - Jeri Basko inquired about the lead time of the computers. James DuPrie advised that it would be a few weeks
  - General Government
    - Insurance
      - Paul Philbrick advised underwriter estimated 15-19% increase due to higher claims activities.
      - Workers Compensation line increased from \$31,500 to \$36,225
      - Liability line increased from \$38,000 to \$45,600
      - Health line increased from \$100,000 to \$150,000
- New Business (Highlights)
  - Contingency
    - Paul Philbrick suggested keeping \$50,000 in contingency. He also advised that \$33,000 has been used thus far.
  - Library
    - Selectmen distributed Library budget proposal packet prepared by Marcy
    - Regular Wages were discussed. Line item increased from \$14,216 to \$15,211.
    - Equipment line was discussed. Chip Harlow inquired about usage. Paul Philbrick advised he would check on it.
    - Book Barn/Library of Things was discussed as a new budget line item.
      After discussion, Chris Gilpatrick Sr. made motion to cut line item out.
      No second. Deborah Wilson made motion to discuss line item without

snowshoes for \$521.82. No second. Chip Harlow made motion to table line item and give it back to Marcy for review. Motion seconded by Chris Gilpatrick Sr. 6 Yes 0 No 3 Abstain

## Recreation

- Wages were discussed. After discussion, motion to cease discussion of wages and that discussion be had by selectmen only at executive session made by Chip Harlow and seconded by Deborah Wilson.
