## Conservation Commission Meeting, Via Zoom June 18, 2020

## *Ryan – Community Forest*

Ryan has come up with some activities for his loop trail at the Community Forest, including stump tic tac toe and measuring a tree games. His last scheduled workday was postponed due to Covid-19, but is rescheduled for Saturday, June 20. He will head out with 10 to 12 folks with hand tools to work on the trail.

John suggested that we name the loop trail Sacapee Pond Trail and come up with a new name for the main trail. Ruth commented that we would need to wait for a map reprinting, but no one was opposed to considering the idea.

Ruth asked the Scouts if they had any guidance from the Scout Org. about safety guidelines during the virus. Eli said fundraising via bake sales had been ruled out, which is unfortunate as they raise a lot of money.

## Eli - Nesbitt Pond

John recapped the visit he, Eli, and Eli's dad made to the pond. Eli proposes to create a parking space, stairs, and boardwalk access to the pond, which could facilitate kayak or canoe entry, in addition to fishing. He will also create signage.

Don asked about the hydrant located at the pond and if we would be impeding the fire department from accessing it. Eli explained that parking would be to the left of the hydrant and it was agreed that language about not blocking the hydrant should be added to the sign. There will be parking for two vehicles and the board agreed that it was unlikely to attract too many visitors at once. CC members will share and agree on what the sign should say and what rules should govern the recreation area. This language will be forwarded to Eli.

Ruth will forward Eli's document of images and information about his project to the other members.

## <u>Old Business</u>

Gully Oven never got its clean up. John will visit to see how things look now and replenish brochures, if needed.

John still has Community Forest signs. We proposed waiting until fall to reschedule our walk and put up the signs at the same time.

George reminded Ruth to mention the ATV club's clean up of the Community Forest and the road. We are grateful for their efforts.

Ruth will check with the town hall about term expiration dates.

July 16, 2020 will be our next meeting date, most likely via Zoom.
