Several things were discussed including a review of the Site Visit from Saturday, December 18, 2021,

- The existing sign will be removed
- There will not be outside traffic, employees only
- There is not the need for a stop sign for the entry/exit is off of Creamery Hill Road
- Placement of the dumpster must be determined. Dumpsters must be completely enclosed by a fence, example six-foot (6') stockade or chain link with privacy slats applicant inquired if they had bins instead of a dumpster if the bins would need to be enclosed, the Board felt that if there were only bins, that they would not have to be enclosed.

Discussion of whether this is a minor or major review took place. Vice-Chairman Wilson made the motion that this be considered a minor site plan review. The motion was seconded by A. Bridges. The vote was taken. The motion carried.

Grace Charland – SPR – 1104 Carl Broggi Highway

Several things were discussed including a review of the Site Visit from Saturday, December 18, 2021,

- waiting for the survey to be completed for the parking lines and setbacks to be added to the plan, buildings need to be labeled
- Has appointment with the dumpster company to determine the best place to set the dumpster
- A completed application still needs to be submitted no later than ten (10) days prior to the Public Hearing
- Applicant is unsure whether or not the existing entrance off of Mills Road will continue to be utilized or closed, Lindsey spoke with Van from the Maine Department of Transportation and waiting for a reply.

- Location of shrubs/plantings are to be placed on site plan
- Letter of intent with the completed application to be submitted at least ten (10) days prior to the Public Hearing
- Applicant is to see the Code Enforcement Officer for a sign permit
- The Board discussed whether this is a minor or major review. Vice-Chair Wilson made the motion that this project should be considered a minor Site Plan Review. The motion was seconded by L. Bragg. The vote was taken. The motion carried.

Tim Bragdon – SPR – 1384 Carl Broggi Highway (Attorney Fredette/Shaun Booker)

M. Bragdon's Attorney Mr. Fredette came before the Board in regard to a Site Plan Review for an existing business. A complete application will need to be submitted. The Land Use Clerk will email the Site Plan Review Ordinance as well as an application.
