Department Head Briefing: Chief Stefano shared that A-1 is back in service, Engine 5 and the Brush Truck should be back in service by the end of the week, Sanford Engine 4 is currently on loan to the Town. The engine purchased recently is still on track for an end of the month delivery at which time familiarization training will be required by the fire crew. Chief Stefano briefed the Board on the results of the delegation meeting held on September 29, 2023. The delegation personnel expressed their willingness to assist with the current situation and will provide support for grant requests. Discussion was held in regards to AFG grants and the need for a specific email address to use for the grant. Chief shared that fire operational training and SCBS technician training was taking place. Lastly, the emergency UTV was back in service after addressing several maintenance issues.

Discussion was held among those present what to do about the conditions of Station 1. Board to review the safety study report results. Reviewed the single wide home proposal. Discussion was held in regards to Station 1 proposed usage and safety guidelines.
