TO LYNNE M. DAVIS, a resident of the Town of Lebanon, in the County of York, State of Maine:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Lebanon, County of York, State of Maine, qualified by law to vote in town affairs, to meet at the Lebanon Elementary School, 65 Upper Guinea Road, Lebanon, Maine on Saturday, May 11, 2024 at 1:00pm for action on Article One, Election of Moderator

Article 1: To choose a moderator to preside at said meeting

Article 2: Shall the Town of Lebanon vote to appropriate up to the total sum of **\$115,000.00** from the Unassigned Fund Balance for the continuation of operations of the Lebanon Fire and EMS Department for the remainder of the 2023/2024 fiscal year which ends on June 30, 2024? Unexpended funds to be returned to the Unassigned Fund Balance.




